

HOUSE AND SENATE COMPLETE FY2007 BUDGET BILLS

Both the House and Senate have completed work on the FY2007 Appropriations Bills for all State Departments, Higher Education, and School Aid albeit on different tracks. The Senate has concluded work to pass individual appropriations bills for the various departments. The House, on the other hand, approved an omnibus bill which includes all state departments in one bill.

Following is an update of action on the FY2006 2007 appropriations bills for the various health and human services departments as well as the education-related bills. Those bills that originated in the Senate have Senate bill numbers. As indicated above, the House combined all Department bills into an omnibus bill (HB 5796) as was done last year; House-originated bills reflect the Omnibus bill number.

Community Colleges (SB 1082) passed the Senate, and the bill is nearly \$44 million GF less than the Executive Budget, and nearly \$46 million general fund lower than the House Appropriations recommendation. The major difference between the Senate-passed bill and the Executive Budget and House recommendation is the Senate substitution of \$43.9 million general fund with funds from the School Aid Fund. The House did not recommend the substitution of general fund dollars with School Aid funds.

Department of Community Health (SB 1083) passed the Senate and is \$54 million general fund lower than the Executive Budget, and nearly \$21 million general fund higher than the House recommendation. Senate-passed changes from the Executive Budget primarily relate to savings assumed from increased copays and premiums for Medicaid recipients, savings in long term care through increased audits and strengthened asset criteria and look-back periods, and reduced funding for Detroit/Wayne Community Mental Health Board. The House

recommendation also assumes increased copays and premiums, as well as long term care savings, but eliminates coverage for optional 19-20 year olds and caretaker relatives. The House recommendation limits the Home Help wage increase to non-relatives, provides a 2 percent increase for Community Health Direct Care Workers, and a 4 percent increase for Medicaid physician rates. The recommendation includes only a \$100 placeholder for the Michigan First Healthcare Plan, while the Senate supported the Governor s'recommendation.

Department of Corrections (SB 1084) passed the Senate and is consistent with the Governor s'general fund recommendation, but is \$30 million general fund higher than the House recommendation. The House recommendation includes savings from efficiencies and program reductions.

Department of Education (SB 1085) passed the Senate and reflects slight modifications from the Executive Budget including a \$350,000 reduction for a best practices study and the restoration of funds for the Alternate Route to Certification and Limited License to Instruct programs. The House recommendation is about \$2 million general fund higher than the Executive Budget and the Senate recommendation. Major changes approved by the House include: \$1.5 million general fund for a web-based practice assessment and classroom remediation program

tion program, \$250,000 for middle school math programs, \$350,000 for curriculum content and revised graduation requirements, \$150,000 reduction for the best practices study.

Michigan League FOR Human Services

Higher Education (SB 1088) passed the Senate and is \$32.8 million general fund higher than the Executive Budget, and \$3.5 million general fund higher than the bill approved by the House. The Senate did not concur with the Governor's recommendations for operational funding for the universities and approved a \$3,750 per student minimum and a 1.8 percent inflation increase for all universities. The Senate provided 2 percent increases to the Agriculture Experiment Station and the Cooperative Extension Service. The Senate also provided \$250,000 for scholarships for a master s'degree in nursing program. The House concurred with the Senate recommendation to increase funding by 2 percent for the Agriculture Experiment Station and the Cooperative Extension Service, and added \$400,000 to the Cooperative Extension Service for 4-H program. In addition, the House recommended a separate formula for operations funding which ranges from a 1.9 percent reduction to a 4.5 percent increase, with an additional \$1 million for Northern Michigan University.

School Aid (SB 1095) passed the Senate, and while the gross and general fund amounts are nearly the same as the Executive Budget, there are numerous policy and funding differences. The Senate-passed bill increases the minimum foundation allowance to \$7,100, \$25 more than the Executive Budget; increases funding for School Readiness programs by \$7.4 million; includes funding for finger printing (\$3.5 million); provides up to \$60/ pupil for those districts with foundation allowances below \$7,160; increased funding for Child and Adolescent Health Centers (\$2 million); and increased Special Education funding by \$52.2 million (\$38.3 million state funds). The Senate did not include funding for 10 initiatives recommended by the Governor, rather the Senate included \$100 placeholders for each of the initiatives. The House recommended a foundation allowance increase of \$230, which is \$30 more than the Executive Budget recommendation, and \$5 more than the increase passed by the Senate. The House included a \$35/pupil increase for districts with foundation allowances below \$7,480, did not include the \$50 million recommended in the Executive Budget for declining enrollment schools nor most of the initiatives recommended by the Governor (the Senate included \$100 placeholders).

Department of Human Services (HB 5796) was approved by the House with dramatic differences from the Executive Budget in both funding and policy. The House recommendation is nearly \$44 million general fund lower than the Executive Budget and includes dramatic changes in the State's welfare programs, including time limits (48 month lifetime, 24 consecutive month limit) for the Family Independence Program, cash assistance grant reductions, elimination of the work incentive, stricter sanction policy, and a family cap. The House bill does include funding for additional staff for several priorities including the Jobs, Education, Training Program (80 FTE s), Child Protective Services (25 FTE s), and Medicaid Eligibility determination (30 FTE s for long term care asset transfer look-back), as well as funding for a contract to assist SSI applicants with appeals. The House bill also includes additional training funds for Work First and employers of Family Independence Program recipients. The Senate passed SB 1090 which includes somewhat less onerous provisions than the bill approved by the House. The Senate bill does not include a time limit for the receipt of Family Independence Program benefits, nor a family cap. It does include sanctions (less strict than the House) and eliminates the \$200/ month work incentive, and assumes a lower payment standard. The Senate also adds staffing for the same program areas as the House, but assumes different staffing numbers, and adds 20 FTE s for licensing investigators for child and adult facilities. The House did not concur with the Governor s' recommendation to replace general fund for educational costs in juvenile justice facilities with school aid funds, and restored the general fund.

Department of Labor and Economic Growth (HB 5796) was approved by the House with a \$100,000 general fund increase from the Executive Budget. The Senate concurred with most recommendations in the Executive Budget with the exception of the liquor license fee increase. The Senate also increased funding for the Bureau of Fire Services by \$1.4 million gross and general fund.

PA 4 - SUPPLEMENTAL BUDGET

Provides zero budget supplemental appropriations for Fiscal Year 2005-2006.

Signed 2/3/06; with line-item vetoes; immediate effect. (SB 956)

PA 20 - INMATE MEDICAL CARE

Requires a county sheriff to draw on an inmate's health care policy before submitting expenses for medical care or treatment to the county.

Signed 2/9/06; immediate effect. (SB 736)

PA 26 - HEALTH FACILITY BACKGROUND CHECKS

Requires an applicant for a health profession license or registration, or for reinstatement or reclassification of a license or registration, to undergo a criminal background check. Also allows a licensing board for good cause to request a licensee or registrant to have a criminal background check.

Signed 2/16/06; immediate effect. (HB 5168)

PA 27 - MENTAL HEALTH BACKGROUND CHECKS

Requires criminal history checks on individuals seeking employment, an independent contract, or clinical privileges with a psychiatric facility or intermediate care facility for people with mental retardation.

Signed 2/16/06; immediate effect. (HB 5448)

PA 28 - RESIDENT CARE BACKGROUND CHECKS

Repeals and replaces provisions that disqualify a person from employment with a nursing home for certain convictions and require criminal history checks of applicants for employment.

Signed 2/16/06; immediate effect. (SB 621)

PA 29 - ADULT CARE BACKGROUND CHECKS

Eliminates the grandfather provision for criminal background checks for employees of adult foster care facilities.

Signed 2/16/06; immediate effect. (SB 622)

PA31 – NEWBORN SCREENING

Creates the Newborn Screening Quality Assurance Advisory Committee.

Signed 2/22/06; immediate effect. (SB 794)

PA 38 - HEALTH RECORD PRIVACY

Allows for the release of patient information without the patient's prior authorization in certain circumstances.

Signed 3/2/06; immediate effect. (HB 4606)

PA 41 - ADOPTION EXAMS

Allows a physician or nurse practitioner to conduct physical examinations and certify a medical statement for preplacement assessments for adoptions.

Signed 3/2/06; immediate effect. (HB 5247)

PA 46 – SEX OFFENDER E-MAIL NOTIFICATION

Requires notification by e-mail to certain individuals when a registered sex offender relocates into or within a certain proximity of a zip code.

Signed 3/2/06; effective 1/1/07. (SB 128)

PA 48 - NURSE EXAMS

Authorizes nurse practitioners to administer medications in schools.

Signed 3/9/06; immediate effect. (HB 5331)

PA 49 - NURSE EXAMS

Allows a certified nurse practitioner to perform a physical examination for any individual ordered to submit to such an examination by a court, board or commission, or other public body or officer.

Signed 3/9/06; immediate effect. (HB 5245)

PA 50 - NURSE EXAMS

Allows nurses to conduct physical examinations for truck driver certifications.

Signed 3/9/06; immediate effect. (HB 5248)

PA 51 - FOSTER CERTIFICATE

Authorizes physician or certified nurse practitioner to complete the medical statement required for licensure or certification as foster parents.

Signed 3/9/06; immediate effect. (HB 5398)

PA 60 - DOMESTIC VIOLENCE CRIMES

Prohibits and provides penalties for damaging, destroying, or preventing access to telecommunications device to prevent reporting of domestic violence, crime, illness or injury.

Signed 3/16/06; immediate effect. (SB 1024)

PA 78 – DOMESTIC VIOLENCE EVIDENCE

Allows prior acts of domestic violence to be admissible as evidence.

Signed 3/23/06; immediate effect. (SB 120)

PA 79 - HEARSAY RULE

Exempts certain statements of domestic violence victims from the hearsay rule.

Signed 3/23/06; immediate effect. (SB 263)

PA 80 - COMMUNITY ACTION AGENCY

Eliminates conflict with departmental rules between community action agency boards.

Signed 3/23/06; immediate effect. (HB 5258)

PA 81 - MINIMUM WAGE INCREASE

Increases the standard minimum wage from \$5.15, as follows: To \$6.95, beginning October 1, 2006; to \$7.15, beginning July 1, 2007; and to \$7.40, beginning July 1, 2008. Specifies, however, that if a ballot proposal establishing a minimum wage is approved by voters at the November 7, 2006 general election, the minimum wage would be set at the rate prescribed by the ballot proposal.

PA 84 - TEACHER CRIMINAL RECORDS

Requires measures to ensure accuracy of reports concerning criminal convictions of school employees, and clarifies disclosure requirements under the Freedom of Information

Signed 3/31/06; immediate effect. (HB 5675)

PA 88 - INMATE COSTS

Provides for reimbursement to municipalities for the cost of housing inmates.

Signed 4/2/06; immediate effect. (SB 208)

PA 90 - SCHOOL SERVICE SAVINGS

Clarifies the procedure to consolidate school services and save tax dollars.

Signed 4/2/06; immediate effect. (SB 866)

PA 91 - CARE IMPROVEMENT REGISTRY

Changes the name of the Childhood Immunization Registry to the Michigan Care Improvement Registry, and requires the Department of Community Health to promulgate rules to implement the expansion of the registry.

Signed 4/4/06; immediate effect. (SB 728)

PA 94 - CAREER PREP SUNSET

Eliminates the June 30, 2006 sunset in the Career and Technical Preparation Act.

Signed 4/2/06; immediate effect. (HB 5282)

PA 105 - PRESUMPTION OF CUSTODY

Revises the information required to be on an acknowledgment of parentage form and specifies that signing the form would give initial custody of a minor child to the mother without prejudice to a court's determination of each parent's custodial rights.

Signed 4/7/06; immediate effect. (HB 4161)

PA 111 & 112 - SBT PROJECT TAX CREDITS

Provides for criteria and qualifications for Single Business Tax (SBT) credits for projects of \$200,000 or less.

Signed 4/7/06; immediate effect. (HB 4733 & 4734)

PA 113 - SBT CREDITS

Requires Single Business Tax (SBT) credits of \$200,000 and amends application requirements.

Signed 4/7/06; effective 90 days after sine die adjournment. (SB 599)

PA 116 - RENAISSANCE ZONES

Provides eligibility for the designation of additional renaissance zones.

Signed 4/11/06: immediate effect. (SB 922)

PA 118 – TEACHING READING REQUIREMENT

Establishes additional requirements regarding reading instruction for the renewal of an elementary teacher's provisional teaching certificate or the advancement of the teacher's certification to professional certification, beginning July 1, 2007.

Signed 4/14/06; immediate effect. (SB 327)

PA 119 – EARLY INTERVENTION PROGRAMS

Allows School Aid funds to be allocated to early intervention programs.

Signed 4/14/06; immediate effect. (SB 328)

PA 120 - EARLY INTERVENTION GRANT PROGRAM

Establishes a grant program for early intervention programs, and redirects funding from districts that formerly received a class size grant to now use those funds for early intervention programs.

Signed 4/14/06; immediate effect. (SB 329)

PA 121 – EARLY INTERVENTION PROGRAMS

Requires a percentage of at-risk funds to be used for early intervention programs in districts with a learning-disabled population above the state average.

Signed 4/14/06; immediate effect. (SB 330)

PA 123 - GRADUATION REQUIREMENTS

Establishes statewide graduation requirements.

Signed 4/20/06; immediate effect. (HB 5606)

PA 124 - HIGH SCHOOL CURRICULUM

Sets requirements for high school curriculum and requires students to pass the curriculum in order to receive a diploma.

Signed 4/20/06; immediate effect. (SB 1124)

Resolutions Adopted

SR 108 - NO CHILD LEFT BEHIND REQUIREMENTS

Urges the U.S. Congress to add social studies to the testing requirements under the No Child Left Behind Act.

Adopted 4/26/06. (Kuipers)

HR 182 - HOME HEATING

Memorializes Congress and the President to increase funding for the Low Income Home Energy Assistance Program (LIHEAP).

Substitute adopted 4/25/06. (Schuitmaker)

HR 204 - CHILD PROTECTION COMMITTEE

Creates a special House Committee on Child Protection. Adopted 3/2/06. (DeRoche)

HR 210 - METH DANGERS

Encourages the Department of Education and school districts to educate teachers and administrators on the dangers of methamphetamine.

Adopted 4/27/06. (Newell)

Vetoes of 2006

SB 179 - YOUTH WORK STANDARDS

Amends the Youth Employment Standards Act to provide that a 16- or 17-year-old student could not work more than 20 hours in one week when school is in session.

Vetoed by the Governor 3/3/06. (Stamas)

SB 957 - SINGLE BUSINESS TAX

Removes the Single Business Tax (SBT) credit alternative tax rate and percentage reduction in tax liability.

Vetoed by the Governor 2/3/06. (Cassis)

<u>SB 1026-1028,</u> – REGULATORY UNION PREFERENCE <u>HB 5744 & 5745</u>

Amends various health care-related statutes to prohibit provisions in administrative rules that discriminate in favor or against a provider based on the existence of a collective bargaining agreement.

Vetoed by the Governor 3/23/06. (Hardiman, et. al.)

HB 5743 - SBT REPEAL

Provides for the repeal of the Single Business Tax (SBT) credit

SB 130 - COACH CONVICTION DISCLOSURE

Requires the disclosure of certain convictions of persons coaching independent youth athletic teams.

Senate passed 5/10/05; House passed substitute 6/29/05; re-referred to House Judiciary 2/28/06. (Sanborn)

SB 183 - CHILD SAFETY SEATS

Requires child safety seats for children 80 pounds or less and under nine years of age.

Introduced 2/10/05; to Transportation; reported favorably with substitute and referred to committee of the whole 2/23/06. (McManus) (Similar to HB 4153 - Kolb.)

SB 262 - CHILD CAR RESTRAINTS

Waives fines for certain child car restraint system violations under certain circumstances.

Introduced 3/1/05; to Transportation; reported favorably without amendments and referred to committee of the whole 2/23/06. (George) (Similar to HB 4152 – Kolb.)

SB 314 - CHILD SAFETY SEATS

Requires a child safety restraint seat to be in the rear seat if a vehicle has a rear seat, and removes the nursing child exemption.

Introduced 3/16/05; to Transportation; reported favorably without amendments and referred to committee of the whole 2/23/06. (Hammerstrom)

SB 491 - VEHICLE CHILD RESTRAINT

Increases the penalties for the failure to properly restrain a child less than 16 years of age in a vehicle for second and subsequent violations.

Introduced 5/11/05; to Transportation; reported favorably with substitute and referred to committee of the whole 2/23/06. (Kuipers)

SB 891 - CHILD SUPPORT

Establishes department responsibilities for child support collection.

Introduced 11/10/05; to Families & Human Services; reported favorably with substitute and referred to committee of the whole 1/25/06. (Hardiman)

SB 1041 – CHILD CAR RESTRAINTS

Requires use of a rear seat child safety restraint system for children younger than 12 in some circumstances.

Introduced 2/8/06; to Transportation; reported favorably without amendments and referred to committee of the whole 2/23/06. (Birkholz)

SB 1110 - CHILD ABUSE

Increases allowable probation time for misdemeanor child abuse.

Senate passed substitute 3/23/06; to House Judiciary 3/23/06. (Garcia)

HB 4121 – WORK FIRST PROGRAM SUNSET

Repeals the sunset date on the Work First Program.

Introduced 2/1/05; to Family & Children Services; reported with recommendation with substitute and referred to second reading 11/30/05; re-referred to Family & Children Services 2/15/06. (Clack)

HB 4957 - CHILD SERVICES ORGANIZATIONS

Enacts sentencing guidelines for the crime of accepting employment or volunteer status with certain entities in which children are present.

House passed substitute 6/29/05; Senate passed substitute 8/31/05; re-referred to Judiciary 2/28/06. (Taub) (Similar to SB 605 – Gilbert.)

HB 5027 - DEVELOPMENT ACCOUNTS

Creates individual and family development accounts.

Introduced 6/29/05; to Banking & Financial Services; substitute adopted and amended and placed on third reading 4/18/06. (Hunter)

HB 5531-5535 - SEX CRIMES AGAINST MINORS

The following bills pertain to violations of criminal sexual conduct against children less than 13 years of age:

HB 5531 provides for mandatory lifetime electronic monitoring of persons convicted of certain criminal sexual conduct crimes, and establishes penalties for tampering with the electronic monitoring device.

HB 5532 provides for a lifetime satellite tracking of certain sex offenders

HB 5533 enacts sentencing guidelines for the crime of tampering with an electronic monitoring device.

HB 5534 provides for a 25-year minimum sentence for first-degree criminal sexual conduct against certain minors.

HB 5535 revises the jurisdiction of the parole board of a prisoner convicted of first-degree criminal sexual conduct against an individual less than 13 years of age, and provides for GPS monitoring during the parole period.

HB 5602 - ADOPTION INHERITANCE RIGHTS

Removes conflicts between the Estates and Protected Individuals Code (EPIC) and the Adoption Code.

House passed substitute 2/16/06; to Senate Judiciary 2/21/06. (Schuitmaker)

HB 5842 - CHILD METH EXPOSURE

Requires the Department of Human Services to cooperate with law enforcement in cases where children have been exposed to methamphetamine production.

House passed substitute 4/27/06. (Mortimer) (Similar to SB 1116 — Hardiman.)

HB 5843 - CHILD METH EXPOSURE

Requires cases of child exposure to methamphetamine production be referred to the prosecuting attorney.

House passed 4/27/06. (Gilbert) (Similar to SB 1117 – Gilbert.)

HB 5844 - CHILD METH EXPOSURE

Establishes reporting requirements for a child suspected of having been exposed to or having had contact with methamphetamine production.

House passed substitute 4/27/06. (Baxter)

SCR 39 - INDIGENT DEFENDANTS

Calls on the State Bar of Michigan and the National Legal Aid and Defender Association to issue a joint report on the number and types of cases, and their costs, of courtappointed attorneys for indigent criminal cases.

HB 5643 - INMATE REIMBURSEMENT COSTS

Extends the time for filing a civil action by counties for reimbursement by inmates to the county for the cost of imprisonment and care.

Ordered enrolled 4/19/06. (Caul)

Education

SB 673 - SCHOOL ADMINISTRATORS

Provides for voluntary certification for school administrators.

Senate passed substitute 9/22/05; to House Education 9/22/05; reported with recommendation without amendments and referred to second reading 4/26/06. (Jelinek)

SB 674 - SCHOOL ADMINISTRATORS

Establishes fees for voluntary school administrator certificates and for school counselor licenses.

Senate passed substitute 9/22/05; to House Education 9/22/05; reported with recommendation without amendments and referred to second reading 4/26/06. (Switalski)

SB 1184 - SPECIAL ED COSTS

Sets responsibility for paying for special education hearing costs.

Senate passed 3/30/06; to House Education 3/30/06. (Kuipers)

HB 4278 – COMMUNITY SERVICE REQUIREMENT

Prohibits a requirement that students perform community service as a condition of graduation.

House passed substitute 2/21/06; to Senate Education 2/22/06. (Gosselin)

HB 4375 - SUICIDE RISK CURRICULUM

Encourages schools to provide instruction programs regarding warning signs and risk factors of suicide and depression.

House passed with amendments 3/29/06; to Senate Education. (Ward)

HB 5301-5310 - U.S. CITIZENSHIP REQUIREMENT

SB 973-976 - BALLOTS

Amends the Michigan Election Law to transfer from the Board of State Canvassers to the State Elections Director responsibilities for canvassing petitions to determine the validity and sufficiency of signatures; performing other constitutional duties concerning ballot petitions; and holding hearings on complaints or to investigate signatures.

HB 4228 - PERMANENT ABSENTEE VOTERS

Requires local clerks or secretaries of a school board to maintain a list of permanent absentee voters.

HB 5648-5650 - CANVASSERS' AUTHORITY

Revises the duties of the Board of State Canvassers concerning ballot question petitions, and includes a court review of a determination made by the State Director of Flections.

HB 5659 – VOTER REGISTRATION

Expands the authority of local clerks to confirm and cancel voter registrations.

SB 802 - ECONOMIC DEVELOPMENT AUTHORITY

The mission of Division on Deaf and Hard of Hearing is to affirm the indisputable rights of deaf and hard of hearing persons to secure effective communication through technical support, informational and referral services, accommodations, interpreter information and services, and research and statistics.

BOARD OF MARRIAGE AND FAMILY THERAPY

The Board is responsible for the promulgation of rules to set minimal standards of acceptable practices and to assess penalties when those standards are not met. The board is also responsible for the recommendation of licensure to schools or individuals that have passed the designated exam created by the board.

Joette M. Lambert, Pleasant Ridge, was appointed to represent the general public for a term expiring 6/30/07. The appointment stands confirmed unless disapproved by the Senate within 60 days.
