Status of bills updated through November 30, 2007.

**2007 Public Acts**

---

**PA 32 – READING TRAINING**

Extends the date for implementing the requirement for current teachers to receive training concerning reading problems.

*Signed 7/1/07; immediate effect. (SB 70)*

**PA 34 – MERIT AWARD FUNDS**

Authorizes transfers of money by the Michigan Higher Education Student Loan Authority to the Merit Trust Fund.

*Signed 7/10/07; immediate effect. (HB 4851)*

**PA 36-40 – MICHIGAN BUSINESS TAX**

PA 36 creates a new business tax system to replace the Single Business Tax which is set to expire on December 31, 2007. PA 37-40 will partially exempt commercial and industrial property from the State Education Tax and local school operating taxes.

*Signed 7/12/07; effective 1/1/08. (SB 94, HB 4369-4372)*

**PA 41 – SUPPLEMENTAL BUDGET**

Provides for multi-department supplemental appropriations for Fiscal Year 2006-2007.

*Signed 7/12/07; immediate effect. (HB 4493)*

**PA 42 – MICHIGAN PROMISE AWARD EXPANSION**

Expands eligibility of the Michigan Promise Award to include certain out-of-state high school graduates.

*Signed 7/12/07; immediate effect. (HB 4595)*

**PA 45 – VOCATIONAL EDUCATION**

Revises the definition of *vocational education* and the use of vocational education funds, and allows for the acquisition of necessary equipment.

*Signed 7/17/07; immediate effect. (SB 188)*

**PA 50 – MICHIGAN TRUST FUND**

Provides general amendments for tobacco securitization to the Michigan Trust Fund.

*Signed 8/13/07; immediate effect. (HB 4884)*

**PA 52 – PRESIDENTIAL PRIMARY**

Sets the Presidential Primary for January 15, 2008, with provisions for the political parties to decide on other means for selecting a presidential candidate; requires voters to indicate a party ballot selection in writing.

*Signed 9/3/07; immediate effect. (SB 624)*

**PA 61 – NEIGHBORHOOD IMPROVEMENT TAX**

Provides for tax increment financing for neighborhood improvement authorities.

*Signed 9/18/07; immediate effect. (SB 69)*

**PA 73 – ESTATE RECOVERY PROGRAM**

Establishes the Estate Recovery Program to recoup Medicaid payments.

*Signed 9/30/07; immediate effect. (SB 204)*

**PA 74 – ESTATE RECOVERY PROGRAM**

Implements the Estate Recovery Program for the Medicaid program.

*Signed 9/30/07; immediate effect. (SB 374)*

### **PA 85 – QUALITY ASSURANCE ASSESSMENTS**

Updates provisions of the Quality Assurance Assessment Program (QAAP) for nursing homes and hospitals related to the amount retained by the state to offset GF/GP funds for Medicaid.

*Signed 9/30/07; immediate effect. (HB 4185)*

### **PA 87 – NONPROFIT FEES**

Revises nonprofit corporation filing fees.

*Signed 9/30/07; immediate effect. (HB 5257)*

### **PA 88 – QUALITY ASSURANCE FEES**

Modifies the collection of quality assurance assessment program fees from health maintenance organizations.

*Signed 9/30/07; immediate effect. (SB 796)*

### **PA 90 – BUSINESS TAX DEDUCTION**

Amends the Michigan Business Tax Act by creating a new deduction for businesses that realize an increase in their deferred tax liability due to the enactment of the new Michigan business tax which takes effect on January 1, 2008.

*Signed 9/30/07; effective 1/1/08. (HB 5104)*

### **PA 91 – CONTINUATION BUDGET**

Creates a continuation budget from October 1 to December 31, 2007.

*Signed 10/1/07; immediate effect. (SB 772)*

### **PA 92 – CONTINUATION BUDGET**

Provides a continuation budget for School Aid.

*Signed 10/1/07; immediate effect. (SB 773)*

### **PA 93 – TAX ON SERVICES**

Amends the Use Tax Act to add certain services to the list of property and services taxed under the Act; the services would be taxed at 6 percent as of December 1, 2007.

*Signed 10/1/07; effective 12/1/07; repealed 12/1/07 (HB 5198)*

### **PA 94 – INCOME TAX RATE INCREASE**

Amends the Income Tax Act to: increase the rate of the income tax temporarily to 4.35%; appropriate \$100,000 to the Department of Treasury for the implementation of the bill's requirements; and add an income tax exemption for qualified disabled veterans.

*Signed 10/1/07; immediate effect. (HB 5194)*

### **PA 95 – STATE EMPLOYEE PENSION FREEZE**

Requires freezing state employee retirement benefits for the period when hired by the state either directly or indirectly.

*Signed 10/1/07; immediate effect. (HB 4800)*

### **PA 96-99 – STATE AGENCY EFFICIENCY**

Public Acts 96 and 97 create the Commission on Government Efficiency to review and investigate ways to make State government more efficient, and review, investigate, and collect information necessary to evaluate each State agency's functions and services.

Public Acts 98 and 99 create the Commission on Statutory Mandates to review and investigate all mandates and reporting requirements in State law, and determine the cost of each.

*Signed 10/1/07; immediate effect. (SB 395-398)*

### **PA 100 – MEDICAID INCENTIVES**

Requests a federal waiver for incentives for Medicaid recipients.

*Signed 10/1/07; immediate effect. (SB 1)*

### **PA 101 – ISD SCHOOL CALENDAR**

Requires an Intermediate School District to establish a common school calendar for all of its constituent districts.

*Signed 10/1/07; immediate effect. (SB 549)*

### **PA 106-109 – PUBLIC EMPLOYEE HEALTH CARE**

The bills allow for the creation of public employer pooled medical plans under certain conditions.

*Signed 10/1/07; immediate effect. (SB 418-421)*

### **PA 110 & 111 – SCHOOL RETIREMENT SYSTEM**

Amends the Public School Employees Retirement System to change the way retiree health benefits would be provided to those entering the retirement system (new school employees) after June 30, 2008; to make changes to provisions dealing with the purchase and use of service credit; and to increase the required contribution to the Member Investment Plan for those entering the retirement system.

*Signed 10/1/07; immediate effect. (SB 546 & 547)*

### **PA 112 – PRISONER MENTAL HEALTH CARE**

Provides for contracting with third parties for mental health services for state prisoners.

*Signed 10/1/07; immediate effect. (SB 622)*

### **PA 118 – LABOR & ECONOMIC GROWTH BUDGET**

Provides appropriations for the Department of Labor and Economic Growth for Fiscal Year 2007-2008.

*Signed 10/31/07 w/line-item vetoes; immediate effect. (SB 234)*

### **PA 119 – EDUCATION BUDGET**

Provides appropriations for the Department of Education for Fiscal Year 2007-2008.

*Signed 10/31/07; immediate effect. (HB 4346)*

### **PA 120 – COMMUNITY COLLEGES BUDGET**

Provides appropriations for the community colleges for Fiscal Year 2007-2008.

*Signed 10/31/07; immediate effect. (HB 4360)*

### **PA 123 – COMMUNITY HEALTH BUDGET**

Provides appropriations for the Department of Community Health for Fiscal Year 2007-2008.

*Signed 10/31/07; immediate effect. (HB 4344)*

### **PA 124 – CORRECTIONS BUDGET**

Provides appropriations for the Department of Corrections for Fiscal Year 2007-2008.

*Signed 10/31/07; immediate effect. (HB 4348)*

### **PA 131 – HUMAN SERVICES BUDGET**

Provides appropriations for the Department of Human Services for Fiscal Year 2007-2008.

*Signed 10/31/07 w/line-item vetoes; immediate effect. (SB 232)*

### **PA 138 – SPECIAL ED DISCIPLINE**

Clarifies relationship of mandatory expulsion provisions for special education students facing disciplinary action with provisions in federal law.

*Signed 11/12/07; immediate effect. (SB 571)*

### **PA 139 – JAIL POPULATION MANAGEMENT PLAN**

Provides for the adoption of a jail population management plan.

*Signed 11/12/07; immediate effect. (HB 4234)*

### **PA 140 – JAIL POPULATION PLAN**

Implements a county jail population management plan and revises jail overcrowding procedures.

*Signed 11/12/07; immediate effect. (HB 4725)*

### **PA 141 – TRANSFER STUDENTS**

Permits the parent or legal guardian of a transfer student who had completed at least two years of high school credit out of State or at a nonpublic school to request additional modifications of the Michigan Merit Standard as part of his or her personal curriculum.

*Signed 11/13/07; immediate effect. (SB 403)*

## **Resolutions Adopted**

---

### **SR 85 – SERVICES TO INMATES**

Urges the Governor to issue an executive directive requiring interdepartmental agreements and cooperation between the Departments of Community Health, Human Services and Corrections to coordinate services to inmates in Michigan's prisons.

*Adopted 9/18/07. (Kuipers)*

### **HR 153 – RETIREE HEALTH CARE REFORM**

Amends the rules of the House to create a seven-member Retiree Health Care Reforms Committee.

*Adopted 7/17/07. (Tobocman)*

### **HR 207 – ELDER ABUSE**

Urges the U.S. Congress to enact federal legislation designed to prevent elder abuse.

*Adopted 10/23/07. (Robert Jones)*

### **HR 219 – CHILDREN'S TRUST FUND**

Celebrates the 25<sup>th</sup> anniversary of the Michigan Children's Trust Fund in honor of its dedication to Michigan's children.

*Adopted 10/29/07. (Sak)*

## BILLS PENDING

Status of bills updated through November 30, 2007.

### Children & Families

#### **SB 241 – CHILD CARE LICENSING**

Revises licensing and registration requirements for child care centers.

*Senate passed substitute with amendments 9/11/07; to House Families & Children's Services 9/11/07; reported with recommendation with substitute and referred to second reading 11/28/07; reported with recommendation and referred to second reading 11/28/07. (Jacobs)*

#### **SB 242 & 243 – CHILD CARE**

Changes the name of family day care home to family *child* care home and group day care home to group *child* care home.

*Senate passed 9/11/07; to House Families & Children's Services 9/11/07; reported with recommendation and referred to second reading 11/28/07. (Jacobs)*

#### **HB 4564 – JOINT CUSTODY MANDATE**

Mandates joint custody in disputes between parents except for limited circumstances.

*Introduced 4/5/07; to Families & Children's Services; reported with recommendation for referral to Judiciary 10/10/07. (Steil)*

#### **HB 4607 – CHILDREN'S SERVICES**

Allows the State Child Abuse and Neglect Prevention Board, upon legislative appropriations or interdepartmental transfer, to fund grants for community-based collaborative prevention services and secondary prevention programs.

*House passed substitute as amended 10/10/07; to Senate Appropriations 10/11/07. (Clack)*

### Consumer Protection

#### **SB 826-833 – MORTGAGE PROTECTION**

SB 826 and SBs 828-833 amend the Mortgage Brokers, Lenders, and Servicers Licensing Act to enact provisions concerning mortgage loan officers. SB 827 amends the Code of Criminal Procedure to delete a sentencing guidelines provision.

*Senate passed substitute 11/1/07; to House Banking & Financial Services 11/6/07. (Richardville, et. al.)*

#### **SCR 20 & SR 119 – MORTGAGE PROTECTION**

Urges the Office of Financial and Insurance Services to continue working on a state-based national mortgage licensing system.

*Senate adopted 11/6/07; to House Banking & Financial Services. (Kahn)*

### Education

#### **SB 482 – MICHIGAN PROMISE ELIGIBILITY**

Adds as a qualification for the Michigan Promise Scholarship Award a qualifying score of the social studies assessment.

*Introduced 5/8/07; to Education; placed on order of third reading with substitute 10/18/07. (Gleason)*

#### **SB 730 – DISABLED REFERENCE**

Amends the Revised School Code to replace references to a "handicapped person" with "person with a disability."

*Senate passed substitute 10/23/07; to House Education 10/23/07; reported with recommendation with substitute and referred to second reading 11/27/07. (Gleason)*

#### **SB 747 – STUDENT ABSENCES**

Requires that school districts grant excused absences for students when a parent is deployed or returns from combat duty.

*Senate passed 10/17/07; to House Military & Veterans Affairs & Homeland Security 10/17/07. (Scott)*

#### **HB 4601 – SCHOOL RETIREE HEALTH FUND**

Establishes a public school employee health care fund.

*Introduced 4/17/07; to Government Operations; reported with recommendation for referral to Retiree & Health Care Reforms 10/23/07. (Hammel)*

#### **HB 4797 & 4798 – TEACHER RETIREMENT BENEFITS**

Amends the Public School Employees Retirement Act to change the way retiree health benefits would be provided to those entering the retirement system (new school employees) after June 30, 2007.

*Introduced 5/17/07; to Education; placed on second reading 5/25/07; re-referred to Education 6/14/07; notice given to discharge committee 9/11/07 through 9/28/07. (Melton & Johnson)*

### **HB 4799 – TEACHER PENSION FREEZE**

Freezes the retirement allowance payments of a retired public school employee if the individual was re-employed in schools, directly or indirectly (including through third-party contracts).

*House passed substitute 5/25/07; Senate passed with amendments 9/23/07; Senate requested return and referred to Senate Education 10/11/07. (Wenke)*

### **HB 5167 & 5168 – PUBLIC SCHOOL RETIREMENT**

Provides for a transition process for public school employees into a defined contribution retirement plan and provides conforming language to amend the Public School Employees Retirement Act.

*Introduced 9/5/07; to Education; notice given to discharge committee 9/15/07 through 9/28/07. (Wenke)*

## **Elections/Legislative Issues**

---

### **HB 4048 – ABSENTEE VOTING**

Provides for the issuance of an absent voter ballot without justification.

*Introduced 1/22/07; to Ethics & Elections; reported with recommendation with substitute and referred to second reading 7/24/07. (Griffin)*

### **HB 4553 – ABSENT VOTER APPLICATION**

Allows mailing of absent voter ballot application to registered electors 60 years of age or older even if an application is not requested.

*House passed substitute 7/25/07; to Senate Campaign & Election Oversight 8/1/07. (Corriveau)*

### **HB 5353 – PRESIDENTIAL PRIMARY**

Cancels the 2008 presidential primary.

*Introduced 10/24/07; to Oversight & Investigations; notice given to discharge committee 11/27/07. (Griffin)*

---

## **Employment & Economy**

---

### **HB 4316 – WORKER FREEDOM**

Creates the Worker Freedom Act. to prohibit employers from forcing employees to attend a meeting at which the primary purpose was to communicate the employer's opinion about a religious or political matter, including the employer's opinion about whether its employees should join or form a union.

*House passed 7/18/07 to Senate Commerce & Tourism 7/19/07. (Meadows)*

### **HB 4443 – UNIONIZATION**

Prohibits state funds from going to employers who engage in activities that discourage unionization.

*Introduced 3/13/07; to Commerce; reported with recommendation for referral to Labor 10/9/07. (Miller)*

### **HB 4600 – STATE EMPLOYEE HEALTH FUND**

Creates a health care reserve fund for retired state employees.

*Introduced 4/17/07; to Government Operations; reported with recommendation for referral to Retiree Health Care Reforms 10/23/07. (Hammel)*

### **HB 4809 – PUBLIC EMPLOYEE HEALTH BENEFITS**

Limits the cost of health benefits for state and local public employees.

*Introduced 5/17/07; to Oversight & Investigations; motion given to discharge committee approved and placed on second reading 5/25/07; re-referred to Oversight & Investigations 10/9/07. (Wenke)*

### **HB 4975 & 4976 – SERVICE CREDIT**

Allows state employees (HB 4975) and public school employees (HB 4976) to purchase service credit towards retirement after working ten years.

*Introduced 6/21/07; to Oversight & Investigations; notice given to discharge committee 9/15/07 through 9/28/07. (Ball)*

### **HB 5169 & 5170 – FIRE AND POLICE RETIREMENT**

Provides for a transition process into a defined contribution retirement plan for fire fighters and police officers (HB 5169) and State Police (HB 5170).

*Introduced 9/5/07; to Government Operations; reported with recommendation for referral to Retiree Health Care Reforms 10/23/07. (Wenke)*

## **Health**

---

### **SB 278 – MI-HEART**

Creates the "Michigan Helping Ensure Affordable and Reliable Treatment (MI-HEART) Act" to, among other things, facilitate the availability, choice, and adoption of private eligible health coverage plans, as well as the purchase of health coverage products at an affordable price.

*Senate passed substitute 10/4/07; to House Health Policy 10/9/07. (George)*



### **SB 280 & 283 – DEPENDENT COVERAGE**

Amends the Nonprofit Health Care Corporation Reform Act and the Insurance Code, respectively, to require a policy or certificate to permit the continuation of hospital or medical care coverage for a child until he or she reached age 26, even if the child were no longer considered a dependent.

*Senate passed substitute 10/4/07; to House Health Policy 10/9/07. (Sanborn & Brown)*

### **SB 710-715 – UNIFORM ANATOMICAL GIFT ACT**

Creates the Uniform Anatomical Gift Act.

*Introduced 9/4/07; to Health Policy; reported favorably with substitute and referred to committee of the whole 11/30/07. (Gleason, et. al.) Similar to HB 4940-4945 – Condino, et. al.)*

### **SB 716 – MEDICAL RECORDS**

Amends the Medical Records Access Act to revise provisions authorizing certain individuals to examine or obtain a person's medical record, and authorizes certain individuals to obtain a deceased person's autopsy report.

*Senate passed 10/18/07; to House Health Policy 10/18/07. (George)*

### **HB 4451 – PREFUNDED RETIREE HEALTH CARE**

Allows counties, cities, villages, and townships, through September 30, 2010, to issue municipal securities (bonds) to pay the costs of an unfunded accrued liability in the provision of post-employment health benefits for retirees.

*Introduced 3/13/07; to Intergovernmental, Urban & Regional Affairs; reported with recommendation for referral to Retiree Health Care Reforms 10/10/07. (Marleau)*

### **HB 4819 – MEDICAL ALERT PROGRAM**

Creates the "Mozelle Senior Medical Alert Act" as the official response to reports of "missing endangered seniors" (65 years of age and older), provides for the broadcasting or publishing of information about such incidents, and provides for certain civil immunity.

*House passed substitute 10/11/07; to Senate Senior Citizens & Veterans Affairs 10/16/07. (Meadows)  
(Similar to SB 681 – Clarke.)*

### **HB 5249 – QUALITY ASSURANCE ASSESSMENT FEES**

Extends the sunset date for the assessment and collection of the quality assurance assessment fees from October 1, 2007 to October 1, 2008.

*House passed 9/24/07; to Senate Appropriations 9/25/07. (Gillard)*

### **HB 5282 – INDIVIDUAL HEALTH PLANS**

Amends the Insurance Code to regulate individual health benefit plans.

*House passed substitute 10/24/07; to Senate Health Policy 10/25/07. (V. Smith)*

### **HB 5283 – INDIVIDUAL HEALTH PLANS**

Amends the Nonprofit Health Care Corporation Reform Act, which regulates Blue Cross and Blue Shield of Michigan, to require nongroup coverage to comply with individual plan regulations under the Insurance Code.

*Introduced 10/11/07; to Insurance; to Senate Health Policy 10/25/07. (Gaffney)*

### **HB 5284 & HB 5285 – INDIVIDUAL HEALTH PLANS**

Permits Blue Cross and Blue Shield to own subsidiaries providing individual health plans.

*House passed with amendments 10/24/07; to Senate Health Policy 10/25/07. (Farrah & Hune)*

### **HCR 22 – HEALTH CARE SYSTEM**

Expresses the commitment of the Michigan Legislature to the development of a health care system that provides comprehensive coverage for all residents.

*House adopted substitute 8/22/07; to Senate Health Policy 8/22/07. (Vagnozzi)*

### **HCR 51 & HR 201 – CHILDREN'S HEALTH PROGRAM**

Urges the U.S. Congress to override the President's veto on expansion of the State Children's Health Insurance Program (SCHIP).

*House adopted 10/11/07; to Senate Appropriations 10/16/07; discharge committee postponed 10/18/07; discharge committee withdrawn 10/24/07. (Dean & Valentine)*

## **Revenues & Appropriations**

---

### **SB 237 – SCHOOL AID BUDGET**

Provides zero budget appropriations for K-12 School Aid for Fiscal Year 2007-2008.

*Senate passed substitute as amended 9/23/07; to House Appropriations 10/9/07; Senate requested return 10/23/07. (Jelinek)*

### **SB 511 – SUPPLEMENTAL BUDGET**

Provides supplemental appropriations for various state departments and agencies for Fiscal Year 2006-2007.

*Senate passed substitute as amended 9/23/07; House passed substitute 11/6/07. (Jelinek)*

## **SB 778 – REVENUE SHARING FORMULA**

Revises the revenue sharing formula for cities and villages.

*Senate passed substitute 9/24/07; to House Intergovernmental, Urban & Regional Affairs 9/24/07. (Pappageorge)*

## **HB 4492 – SUPPLEMENTAL BUDGET**

Provides appropriations for various state departments for Fiscal Year 2006-2007.

*House passed substitute as amended 8/8/07; to Senate Appropriations 8/30/07. (Cushingberry)*

## **HB 5217 – REVENUE SHARING FREEZE**

Extends the revenue sharing freeze for Fiscal Year 2008.

*House passed substitute as amended 9/23/07; Senate passed substitute 10/17/07. (Tobocman)*

## **Social Services**

---

### **SB 668-672 – FOSTER CARE**

The following bills would amend the Juvenile Code to revise provisions concerning the placement of children in foster care:

**SB 668** – Clarifies termination of parental rights and parenting time.

**SB 669** – Clarifies the foster care permanency plan and the permanent placement of a child.

**SB 670** – Revises notice regarding the termination of parental rights.

**SB 671** – Permits efforts to finalize an alternate permanency plan for a child to be made concurrently with efforts to reunify the child with his or her family.

**SB 672** – Permits the court to appoint a guardian for a child who remained in placement after parental rights had been terminated.

*Senate passed substitute 10/3/07; to House Families & Children's Services 10/3/07. (Hardiman, et. al.)*

### **HB 4284 – ADULT FOSTER CARE**

Allows Medicaid-eligible individuals to receive services related to care (e.g., assisted living) provided in an adult foster care facility licensed under the Adult Foster Care Facility Licensing Act; the Department of Community Health would be required to seek a waiver from the U.S. Department of Health and Human Services to provide adult foster care-related services.

*Introduced 2/20/07; to Families & Children's Services; placed on second reading 5/25/07; re-referred to Families & Children's Services 10/9/07. (Ball)*

## **Taxes**

---

### **SB 53 & HB 4120 – CITY FUND CONTRIBUTION**

Allows cities with income taxes to create tax checkoffs for charitable and public safety purposes.

*Senate passed SB 53 with substitute as amended 3/28/07; House passed substitute 8/21/07. House passed HB 4120 with amendments 2/27/07; Senate passed substitute as amended 3/28/07; Senate substitute concurred in as substituted 8/21/07; returned from House with substitute to Senate substitute 8/22/07. (Whitmer & Bauer)*

### **SB 111 – MOBILE HOME TAX**

Provides penalties to mobile home park owners for failing to remit the required assessment tax.

*Senate passed substitute 8/22/07; to House Intergovernmental, Urban & Regional Affairs 8/22/07; reported with recommendation and referred to second reading 11/7/07; placed on third reading 11/26/07. (Jelinek)*

### **SB 328 – TOBACCO TAX**

Increases the tobacco tax.

*Introduced 3/1/07; to Finance; discharge committee approved and placed on order of general orders 3/15/07; referred to Finance 10/3/07. (Basham) (Similar to HB 4389 – Young.)*

### **SB 687 – DEFERRED TAX LIABILITY**

Allows for deferred tax liability deduction under the Michigan Business Tax.

*Senate passed substitute 9/5/07; to House Tax Policy 9/5/07; placed on second reading 9/26/07; re-referred to Tax Policy 10/9/07. (Gilbert)*

### **SB 838 – SERVICE TAX REPEAL**

Repeals the new tax on services.

*Senate passed substitute 11/7/07; to House Tax Policy 11/7/08; notice given to discharge committee 11/8/07; motion to discharge committee postponed for the day 11/26/07. (Cassis) (Similar to SB 824 – Brown & HB 5373 – Hildenbrand.)*

### **SB 845 – USE TAX**

Sets declining rate on tax assessed on services.

### **BARRIER FREE DESIGN BOARD**

The Board has the responsibility of receiving, reviewing, and processing requests for exceptions to the barrier free design specifications, requiring appropriate equivalent alternatives when exceptions are granted, and receiving, processing, and making recommendations for barrier free design rules.

**Roger L. Donaldson**, Holt, was appointed to represent architects for a term expiring 10/31/08, and **Daryl D. Domke**, Grand Rapids, was appointed to represent wheelchair users for a term expiring 10/31/09. The appointments stand confirmed unless disapproved by the Senate within 60 days.

### **COMMISSION FOR THE BLIND**

The Commission serves approximately 4,500 blind persons each year through its programs: vocational rehabilitation services, independent living services, deaf blind services, youth services, the business enterprise program, and the MCB Training Center.

Appointed for terms expiring 9/30/10 were **Mark A. Eagle**, Lansing, to represent blind persons, and **Margaret Wolfe**, Ann Arbor, to represent the general public. The appointments stand confirmed unless disapproved by the Michigan Senate within 60 days.

### **DOMESTIC VIOLENCE PREVENTION AND TREATMENT BOARD**

The Board is responsible for administering state and federal funding for domestic violence shelters and advocacy services, developing and recommending policy, and developing and providing technical assistance and training.

**Jerry Dorsey IV**, Farmington Hills, was appointed to represent persons with experience in an area related to the problems of domestic violence for a term expiring 9/30/10. The appointment stands confirmed unless disapproved by the Senate within 60 days.

### **EDUCATION TRUST BOARD OF DIRECTORS**

The Board provides an avenue for families to invest in their children's future, enabling them to attend a Michigan institution of higher education.

Appointed for terms expiring 12/31/08 were **Gregory L. Clevenger**, Grand Blanc, to represent nominees of the majority leader of the state Senate with knowledge, skill and experience in the academic, business or financial fields; **Marlene E. Davis**, Southfield, to represent nominees of the Speaker of the House of Representatives with knowledge, skill and experience in the academic, business or financial fields; and **John H. Hale III**, Franklin, to represent persons with knowledge, skill and experience in the academic, business or financial fields. Also appointed was **Albert L. Lorenzo**, Ph.D., Clinton Township, to represent presidents of community or junior colleges for a term expiring 12/31/09. The appointments stand confirmed unless disapproved by the Senate within 60 days.

### **CERTIFICATE OF NEED COMMISSION**

This bipartisan Commission reviews and determines the need for new institutional health services, facilities, or organizations being offered or developed in Michigan.

**Thomas M. Smith**, Saginaw, was appointed to represent companies that are self-insured for health coverage for a term expiring 4/9/10. The appointment stands confirmed unless disapproved by the Senate within 60 days.

## **BOARD OF MEDICINE**

The Board is responsible for the examination and licensing of persons prior to their entry into the practice of allopathic medicine in Michigan. The Board also establishes minimal standards of acceptable practice and assesses penalties for when those standards are not met as well as recommends licensure to schools or individuals once the designated exam, which is created by the board, is passed.

**Nathaniel Smith-Tyge**, Allen Park, was appointed to represent the general public for a term expiring 12/31/10. The appointment stands confirmed unless disapproved by the Michigan Senate within 60 days.

## **HEALTH INFORMATION TECHNOLOGY COMMISSION**

The Commission's mission is to facilitate and promote the design, implementation, operation, and maintenance of an interoperable health care information infrastructure in Michigan.

**Kimberly G. Ross**, Dewitt, was appointed to represent pharmaceutical manufacturers for a term expiring 8/3/08.

**Robert T. Scott, D.O.**, Williamston was appointed to represent doctors of osteopathic medicine and surgery for a term expiring 8/3/11. The appointments are subject to the advice and consent of the Senate.

## **BOARD OF NURSING**

The Board is responsible for the interpretation of licensure and examination of registered professional nurses, licensed practical nurses, and for the certification of nursing specialists. The Board sets minimum standards of practice and assesses penalties when those standards are not met and recommend licensure to schools that provide nursing programs.

Appointed to represent the general public were **Regina D. Allen**, Lansing, for a term expiring 6/30/11; **Suzanne M. Bosek**, Royal Oak, for a term expiring 6/30/10; and **Terese E. Cole**, Flint, for a term expiring 6/30/10. **Melynda J. Daley**, Marquette, was appointed to represent licensed practical nurses for a term expiring 6/30/08.

## **MICHIGAN STATE HOUSING DEVELOPMENT AUTHORITY (MSHDA)**

MSHDA, a bipartisan entity, provides financial and technical assistance through public and private partnerships to create and preserve decent, affordable housing for low- and moderate-income Michigan residents.

**Ismael Ahmed**, Dearborn, director of the Department of Human Services, was appointed to represent principal heads of the executive branch of state government for a

term expiring at the pleasure of the governor. **Bernard S. Glieberman**, West Bloomfield, was appointed for a term expiring 3/10/10. Appointed to represent Democrats for terms expiring 3/10/11 were **Marianne Udow-Phillips**, Ann Arbor, director of the Center for Healthcare Quality and Transformation and former director of the Department of Human Services, and **Archie L. Clark**, Ecorse, president and CEO of Progressive Parking LTD. The appointments stand confirmed unless disapproved by the Michigan Senate within 60 days.

## **COUNCIL FOR LABOR AND ECONOMIC GROWTH**

The Council is charged with assessing trends and issues, developing strategies, and acting as an ongoing strategic advising body that encourages and stimulates innovative public and private responses to workforce challenges.

Appointed to represent business for terms expiring 4/30/11 were **David Adams**, Brighton, **Jumana Judeh**, Dearborn Heights, and **Karen S. Kosniewski**, Royal Oak. The appointments are not subject to disapproval by the Michigan Senate.

## **VETERANS' TRUST FUND BOARD OF TRUSTEES**

The Board provides for temporary assistance to veterans and their dependants for emergency and educational purposes from the earnings of funds. The fund also dispenses tuition funding to children of veterans 100 percent disabled or who were killed in service.

**John H. Skinner**, Schoolcraft, was appointed to represent the American Legion for a term expiring 2/25/10. The appointment is not subject to disapproval by the Michigan Senate.

## **WOMEN'S COMMISSION**

The Commission, housed within the Department of Civil Rights, focuses on improving quality of life for women in the state by studying and reviewing the status of Michigan women; directing attention to critical issues that women face; recommending methods to overcome discrimination; promoting methods for women to develop their skills; conducting surveys and establishing advisory committees on vital issues; and recognizing the accomplishments of women in Michigan.

The following were appointed to represent the general public: **Pamela M. Faris**, Clio, for a term expiring 7/15/08; **Estelle P. Smyth**, Escanaba, for a term expiring 7/15/09; and **Donna L. Budnick**, Harbor Springs, **Ronda E. Stryker**, Portage, and **Alexandra S. Matish**, Ann Arbor, for terms expiring 7/15/10. All appointments stand confirmed unless disapproved by the Senate within 60 days.
